North West Leicestershire District Council appoints new Chief Executive



At a meeting of Full Council on Tuesday 10 May 2022, councillors agreed to

appoint Allison Thomas, who will join the authority in August. Allison Thomas is currently Strategic Director for Service Delivery at neighbouring South Derbyshire District Council, a role she has held for four years.

Picture of Allison Thomas, the Chief Executive of North West Leicestershire District Council. Before this, Allison spent 21 years with Derbyshire County Council in a variety of roles, including Service Director for Transport and the Environment.

Speaking of her appointment, Allison Thomas said: "Working just across the border in South Derbyshire, I've been impressed by the work that North West Leicestershire District Council does with its strong track record of partnership working, and I'm looking forward to taking up my position as Chief Executive.

"I'm looking forward to meeting colleagues at the council and across partnership organisations, and really getting to know the district through the council's work."

To provide leadership in the time before Allison takes up the position, NWLDC has appointed an interim Chief Executive Joanna Davidson, an experienced Chief Executive and local government consultant, who took up the position last week.

Energy Rebate Payment Update

Payments will be made in daily batches to a total of 27,333 customers starting with customers who paid by direct debit on 1 April before moving onto those who paid on 14 April then those who paid on the 28 April.

We expect to have made payments to the majority of direct debit customers by the end of May.

There are a small number of direct debit customers for whom payments will take longer to process. For instance, if the name of the bank account is different from the name of the council tax account holder we will send a letter to collect your rebate from the Post Office. This is a manual process so please advise people to bear with us. If we cannot match your direct debit and council tax account details, residents will receive a letter within the next three weeks with instructions on how to claim their payment at the post office.

What if they don't pay by direct debit?

If residents don't pay their council tax by direct debit they will receive a letter within the next three weeks with instructions on how to claim their payment at the Post Office. Residents don't need to apply for this, if they are eligible, they will receive their payment.

For households who need help with their energy bills but are not eligible for the main energy rebate payment, the details of the discretionary scheme will be published shortly. We are still

awaiting software to allow these payments to be processed.
